- 14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ► During 2014 Plains GP Holdings, L.P ("PAGP") declared and paid cash distributions to its Class A shareholders of record as follows:
- \$.12505 per share per share to shareholders of record at the close of business on January 31, 2014. The distribution was paid on February 14, 2014.
- \$.17055 per share per share to shareholders of record at the close of business on May 2, 2014. The distribution was paid on May 15, 2014.
- \$.18340 per share per share to shareholders of record at the close of business on August 1, 2014. The distribution was paid on August 14, 2014.
- \$.19075 per share per share to shareholders of record at the close of business on October 31, 2014. The distribution was paid on November 14, 2014.
- 15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ► The above referenced PAGP cash distributions made during the calendar tax year of 2014 are a non-taxable return of capital to the extent of a Class A shareholder's tax basis in each PAGP Class A Share and a reduction in the tax basis of that Class A Share. Any cash distribution to the extent it exceeds a Class A Shareholder's tax basis is taxable as capital gains.
- 16** Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ► PAGP has filed its 2014 US corporate income tax return and has determined that the cash distributions for 2014 were in excess of its current and accumulated earnings and profits and therefore a non-taxable return of capital.
