14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ **PLAINS GP HOLDINGS, LP paid a quarterly distribution on November 14, 2016 to Class A shareholders of record at the close of business on October 31, 2016. At this time, based on reasonable assumptions by PLAINS GP HOLDINGS, LP, this cash distribution is expected to be a non-taxable return of capital as PLAINS GP HOLDINGS, LP is not expected to have any current or accumulated earnings and profits in 2016. Pursuant to the applicable Treasury Regulations under Section 6045B, if these assumptions turn out to be incorrect, PLAINS GP HOLDINGS, LP will file a corrected form 8937 within 45 days of such determination.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **PLAINS GP HOLDINGS, LP paid a distribution of \$0.2065 per Class A share on November 14, 2016. At this time, based on reasonable assumptions by PLAINS GP HOLDINGS, LP, this cash distribution is expected to be a non-taxable return of capital to the extent of a Class A Shareholder's tax basis in each PAGP Class A Share and a reduction in the tax basis of that Class A Share. Any cash distribution to the extent it exceeds a Class A Shareholder's tax basis is taxable as capital gains.**
