Sixty courts to use solution for conducting face-to-face court sessions entirely online

The mobile, secure platform is maintained and hosted by Tyler on Amazon Web Services and can be accessed on any device.

After the hearing concludes, Tyler Virtual Court sends an automated summary to the defendant with a link to Incode<sup>®</sup> court's online resolution tool so defendants can take immediate action.
